Dear Shareholder,

Important information: Migration of Service Providers and update to Currency Hedged Share Classes

We recommend you read this letter, but no action is required.

As you are a Shareholder in one or more of the funds of the SICAVs, we are writing to inform you that the Board of Directors of the SICAVs (the “**Board**”), following thorough due diligence and market investigations, has decided to replace certain service providers with effect from 23 February 2026 (the “**Effective Date**”).

Please see the appendix attached for a list of the funds of the SICAVs impacted by these changes.

For any capitalised terms that are not specifically defined within this letter, please refer to the definition in the “Glossary” section of the relevant Prospectus which is available on our website www.columbiathreadneedle.com.

What is changing?

From the Effective Date, Citibank Europe plc, Luxembourg Branch will be replaced by State Street Bank International GmbH, Luxembourg Branch (“**State Street**”) as Depositary, Domiciliary, Administrative and Paying Agent. As a result of the change of Domiciliary Agent, the registered address of the SICAVs will change from 31, Z.A. Bourmicht, L-8070 Bertrange to 49, Avenue J.F. Kennedy, L-1855 Luxembourg.

State Street will perform key functions including, but not limited to, custody and safekeeping of assets, ensuring investments align with the SICAVs’ investment objectives and policies, and accurate valuation of the SICAVs. State Street has provided independent depositary services for Luxembourg funds since 1990, including other funds within the Columbia Threadneedle Investments range.

This migration will not impact the portfolio management of the SICAVs’ assets.

Why are we making these changes?

Following a competitive tender process covering depositary services, fund administration, and custody, the Board concluded that State Street is better positioned to provide effective, and enhanced services. The Board believes this change is in the best interests of Shareholders.

Impact on Costs

The costs for these services are covered under the existing fixed rates for Operating Expenses for each fund (as defined in the relevant Prospectus). There will be no increase in the costs and charges you currently pay.

Update for Currency Hedged Share Classes

For currency hedged share classes only, we are also updating how hedging costs are applied. A hedged share class aims to reduce the impact of exchange rate fluctuations between a fund's base currency and the hedged share class currency. If applicable, currency hedged share classes of the SICAVs are represented by a "H" or "C" in the third letter of the share class name.

Currently, an annual cost of 0.09% is applied via monthly foreign exchange adjustments on the currency hedging transactions undertaken. This cost is reflected in transaction costs, rather than in the Ongoing Charges Figure (OCF).

Following the transition to State Street, a fixed rate of 0.025% will apply to all assets under management in currency hedged share classes. This will result in a 0.065% cost reduction, although the cost will now appear in the OCF instead of transaction costs. While this will show as a small increase in the OCF, the overall cost to Shareholders will decrease.

What do I need to do?

You do not need to do anything as a result of these changes, which will take effect automatically on the Effective Date.

What can I do if I disagree with the changes?

Shareholders may redeem their shares, free of any charges, by submitting a written request to the Registrar and Transfer Agent: SS&C Administration Services Luxembourg, S.A. until 15.00 Luxembourg time on 20 February 2026. Such redemption or exchange requests will be processed in the normal manner in accordance with the Prospectus. Contact details for our Transfer Agent are available below.


