David spent 12 years prior in the accounting profession, including four years as a partner at Deloitte & Touche LLP and three years as a partner at Andersen. He has worked in the financial services industry since 1994. David holds a BA in Accounting and Economics and is a member of the Institute of Chartered Accountants in Scotland.
