## **Change of Depositary and Custodian**

**We recommend you read this letter, but no action is required.**

As an investor in one or more of the sub-funds of the Companies and/or Trust listed below (the Companies and the Trust, together, the “Funds”), we are writing to let you know that State Street Trustees Limited (“State Street”) has been appointed as the new Depositary<sup>1</sup> of the Funds.

The Companies are:

- Columbia Threadneedle Investment Funds (UK) ICVC;
- Columbia Threadneedle Specialist Funds (UK) ICVC;
- Columbia Threadneedle Opportunities Funds (UK) ICVC; and
- CT UK Property Alternative Investment Fund.

The Trust is:

- CT UK Property Authorised Trust.

The appointment of State Street as Depositary for the Funds was completed on 30 March.

Please see the appendix for a list of the Funds, and their sub-funds impacted by the change of Depositary.

State Street has provided fully independent depositary services for UK funds since 1994, including other funds within our range of UK domiciled funds. The Depositary performs an important function in respect of the Funds and is responsible for the custody and safekeeping of

the Funds' assets, ensuring investments are in line with each sub-fund's objective and policy, and that the Funds are being valued correctly. State Street delegates custody and safekeeping services to State Street Bank and Trust Company, an affiliate company.

As a result of these changes, Citibank UK Limited has been retired as Depositary and Citibank N.A. retired as Custodian of the Funds.

There is a reduction in the overall costs and charges you pay. Details of the new fees and charges are available in the "Depositary's fee" and "Depositary's expenses" sections of the prospectuses of the Funds.

These changes have been reflected in the revised version of the Funds' prospectuses which are available at [www.columbiathreadneedle.co.uk](http://www.columbiathreadneedle.co.uk)

### **Costs**

The costs associated with making these changes are paid for by Columbia Threadneedle Investments.

### **What do I need to do?**


You do not need to take any action in respect of this update. There is no change to how the sub-funds of the Funds are managed as a result of the appointment of the new depositary and custodian.
