**Threadneedle Investment Services Limited ("TISL") - Important administrative change – Action required**

We are writing to inform you of a change we are making to the banking services provider for TISL funds. From 9 June 2025, the banking services provider for TISL will change from the Bank of America ("BoA") to NatWest Group plc ("NatWest").

Please note, this change impacts only TISL funds, and our other OEIC and SICAV ranges will not be affected. A full list of the impacted ISINs can be found on our website:

**Why are we making these changes?**

Following a recent announcement from BoA that they will cease their cheque banking services from July 2025, we have opted to change the bank account provider to NatWest, who will provide these services for all GBP onshore accounts from June 2025.

**The effective date of this change is 9 June 2025**

The transition from BoA to NatWest is set to take place on 9 June 2025. Proceeds received for trade settlement on 8 June, or before, must continue to be paid to the BoA account. Proceeds for any trades due to settle on 9 June or later will need to be instructed to the NatWest account details below.

Please note that if settlement reaches the NatWest account prior to 9 June, the proceeds will be automatically returned to the sender.

Please update your records to reflect the new bank details shown in this letter, which will become effective on 9 June 2025.
