Company Summary

The Company

The Company is an investment trust and was launched on 16 April 2008. Its shares are listed on the Official List and traded on the main market of the London Stock Exchange. It is a member of the Association of Investment Companies ('AIC').

Net assets attributable to shareholders at 31 May 2011 were £23.3 million (Income shares) and £20.7 million (Growth shares).

Investment Objective

The Company's investment objective is to provide an attractive level of income with the potential for income and capital growth to Income shareholders and to provide capital growth for Growth shareholders, in each case through investing principally in a diversified portfolio of investment companies.

The Company's investments are managed in two separate portfolios: the Income Portfolio and the Growth Portfolio, to which the Income shares and the Growth shares are respectively entitled.

The benchmark index for both the Income Portfolio and the Growth Portfolio is the FTSE All-Share Index.

Investment Policy

The Company's investment policy is set out in the Report of the Directors on pages 15 to 16.

Management

The Board has appointed F&C Investment Business Limited (the 'Manager'), a wholly-owned subsidiary of F&C Asset Management plc, as investment manager. Details of the management contract, are provided in note 4 to the Accounts.

Capital Structure

The Company has two classes of shares, Income shares and Growth shares. Details of the Capital Structure are provided on pages 27 and 28.

In addition, the Company has a borrowing facility with its custodian JPMorgan Chase Bank.

How to Invest

F&C Asset Management plc operates a number of investment plans which facilitate investment in the Income shares and Growth shares of the Company. Details are contained on page 55.

You may also invest through a stockbroker.

ISA Status

The Company's shares are eligible for Individual Savings Accounts ('ISAs').

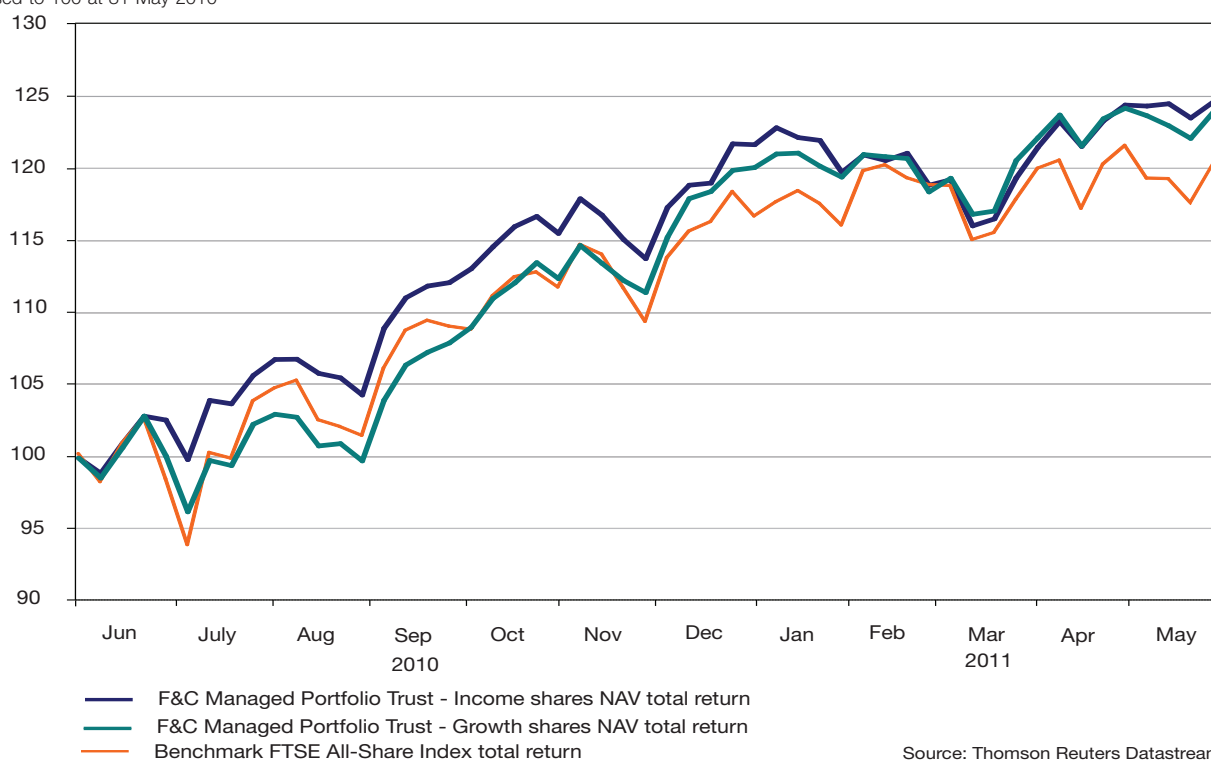

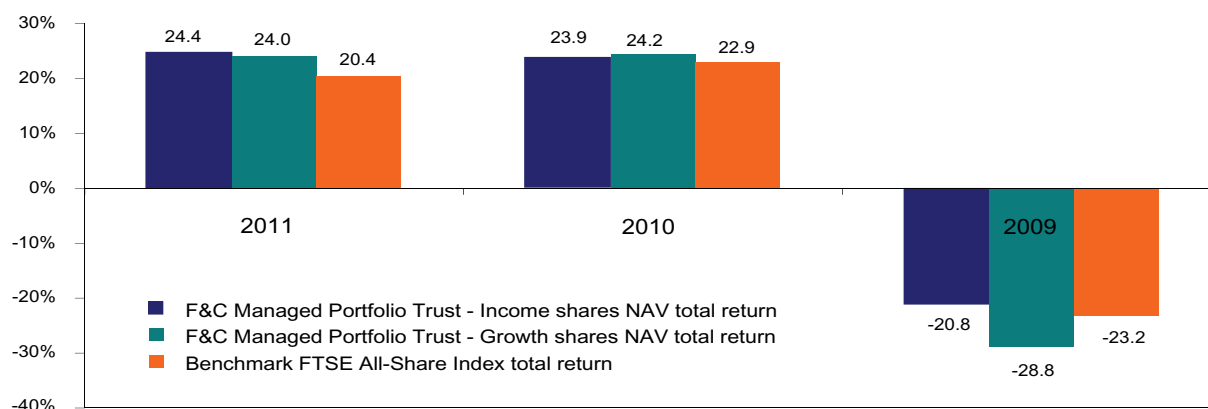

Chairman's Statement

Highlights

- Strong NAV total returns for both the Income shares (+24.4%) and Growth shares (+24.0%)
- Both share classes beat their benchmark, the FTSE All-Share Index
- Annual dividend maintained at 4.4p per Income share for the year
- Both shares traded at a small premium to NAV on average during the year

Introduction

This was another strong year for the UK equity market – and indeed many overseas markets too. News on economic growth was at best patchy, but corporate results were robust. With interest rates at rock bottom, savers turned to equities in the search for reasonable yields.

Across the investment trust sector there was some reduction in average discounts but the outperformance largely came from good selection by our manager, Peter Hewitt.

It was particularly pleasing to see another year of strong performance from the Growth shares; however, given a particularly difficult period in late 2008, during the financial crisis, the Growth shares remain behind the benchmark index when measured since launch.

Performance

For the Company's financial year to 31 May 2011, the total return (i.e. adding dividends paid to capital performance) of the FTSE All-Share Index was 20.4%. This index is the performance benchmark for both Portfolios.

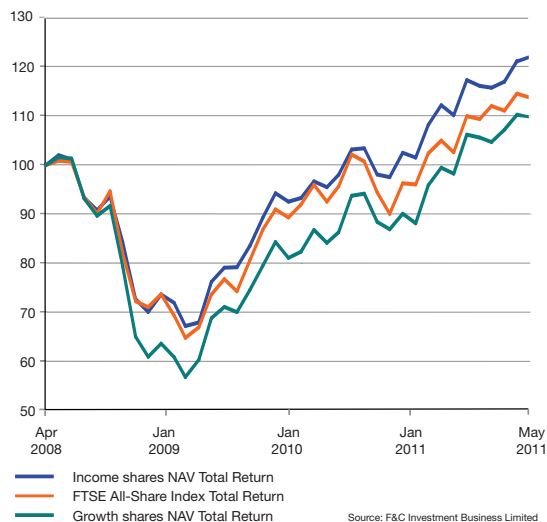
The net asset value ('NAV') per share of the Income shares rose by 18.8% to 103.09p. With the four dividends paid out during the year included, the total return of 24.4% was ahead of the benchmark.

The NAV per share of the Growth shares rose by 24.0% to 107.52p per share and was also ahead of the benchmark.

Since launch in April 2008, the NAV per share total return of the Income shares is 22.0% and 9.7% for the Growth shares which compares to a total return of 13.7% from the benchmark index.

Dividends

Under the Company's capital structure any net revenue arising on the Growth Portfolio is transferred to the Income Portfolio in exchange for a capital contribution of an identical amount. The net revenue return for the Growth shares for the year to 31 May 2011 totalled £89,000, which is equivalent to 0.4p per Income share. Including this transfer, the Company's net revenue return was £927,000 which is equivalent to 4.20p per Income share.

Four interim dividends with respect to the year to 31 May 2011 have now been paid, totalling 4.4p per Income share. This is at the same annual rate as in the previous year to 31 May 2010. The fourth interim dividend was paid after the year end on 8 July 2011. In order to maintain the annual dividend rate, £52,000 was utilised from the revenue reserve, which now totals £78,000 or 0.35p per Income share. As referred to in my Statement last year a number of investee companies accelerated the payment of their dividends prior to the end of the last tax year on 5 April 2010, which contributed in part to the lower level of net income in the financial year under review. As the Company's income is recognised when dividends from our investments are marked ex dividend, any changes in the timing of these will impact the net revenue position.

As before, in the absence of unforeseen circumstances, your Board intends to declare three interim dividends, each of 1p per Income share payable in October 2011, January 2012 and April 2012. It is intended that a fourth interim dividend will be paid to Income shareholders in July 2012 but the directors will determine the amount of the fourth interim dividend when a clearer view emerges of income for the year to 31 May 2012.

Dividends paid by companies in the FTSE All-Share index are estimated to rise by some 10% over the current calendar year. In time this should feed through to an increase in payments from investment trusts, although some may be retained to re-build revenue reserves.

Borrowing

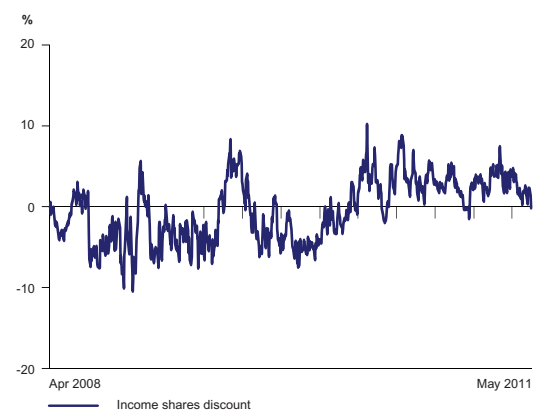
Early in the year borrowings of approximately £1 million were drawn down for the Income Portfolio and amounted to 4.2% of that Portfolio at the end of the financial year. The funds were invested primarily into existing holdings with higher yields, producing a net contribution to income after deducting interest charges.

At the time of writing borrowings in the Income Portfolio total £1.4 million but we are unlikely to increase this unless the market outlook improves significantly.

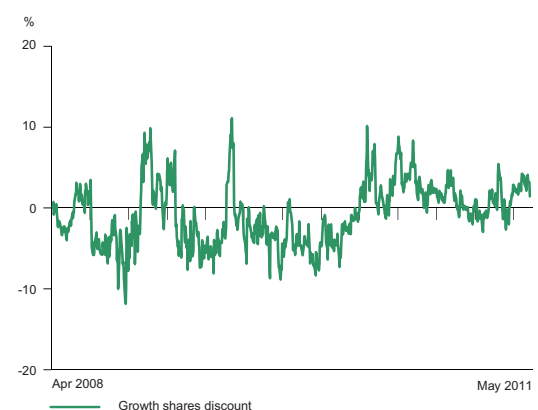
Discounts and share buy-backs

The share price of investment trusts does not always reflect closely their underlying NAV and many trusts trade at a substantial discount. In normal circumstances we aim to maintain our discount at not more than 5% by buying back shares from time to time. During the year to 31 May 2011 we have been able to maintain an average premium of 2.9% for the Income shares and 1.7% for the Growth shares. At the year end, the ratings were a discount of 0.1% for the Income shares and a premium of 1.4% for the Growth shares.

By maintaining these ratings we have been able to sell shares from treasury and issue new shares to meet demand. During the year the Company sold all 427,000 Income shares held in treasury and issued 650,000 Income shares from its block listing facility (part of the potential 9.99% increase in share capital

which shareholders approved at the last AGM). In total 1,910,000 Growth shares were also sold from treasury and 485,000 Growth shares were bought back to be held in treasury. In addition 440,000 Growth shares were issued from the block listing facility. These Income and Growth shares were sold at a small premium to NAV, thereby providing a modest enhancement to the NAV of both share classes.

Demand for the Company's shares has been boosted by investors through the F&C savings plans.

We will be seeking shareholders' approval to renew the powers to allot shares, buy back shares and sell shares from treasury at the Annual General Meeting.

Share plans and conversion facility

Subject to minimum thresholds, shareholders have the opportunity to convert their Income shares into Growth shares or their Growth shares into Income shares upon certain dates every year, the next of which will be 28 October 2011. Information is provided on pages 53 and 54 and full details will be provided on the Company's website (www.fcmanagedportfolio.co.uk) from 29 July 2011. Since launch no conversion has yet taken place as the number of shares offered for conversion has been well below the minimum threshold.

AGM

The annual general meeting ("AGM") will be held at 12.30pm on Tuesday 20 September 2011 and I hope you will attend. The meeting will be held in the offices of F&C Asset Management plc at Exchange House, Primrose Street, London.

Outlook

It is becoming clear that the problems which emerged so dramatically in the financial crisis of 2008-9 are far from resolved. Western economies face several years of slow growth, hampered by high levels of state and personal debt and ageing populations. Even with interest rates at all-time lows and the application of extensive programmes of stimulation, economic growth is faltering again. European politicians have proved woefully slow in tackling sovereign debt crises in the eurozone periphery.

Fortunately the corporate sector appears in generally robust shape, benefitting from strong balance sheets and a trend towards greater global trading. We believe that a well-diversified portfolio of investment companies provides valuable "defence in depth" to weather these challenging times.

F&C Managed Portfolio Trust plc is managed by F&C Investment Business Limited, a wholly-owned subsidiary of F&C Asset Management plc (F&C). F&C is a leading asset manager in both the UK and Europe with some £106.1 billion (at 31 March 2011) of funds under management. F&C is a company listed on the London Stock Exchange.

F&C provides management and other services to a range of investment clients.

Investment Process

The investments of F&C Managed Portfolio Trust are managed in two separate portfolios, the Income Portfolio and the Growth Portfolio, to which the Income shares and the Growth shares are respectively entitled.

Income Portfolio

The objective for the Income Portfolio is to provide investors with an attractive level of income, with the potential for income and capital growth, from a diversified portfolio of investment companies.

The Income Portfolio holds a portfolio of investment companies which focus on offering an income yield above the yield of the FTSE All-Share Index and is

diversified through holding at least 25 investments. Each underlying investment provides further diversification through holding a significant number of underlying investments.

The benchmark index for the Income Portfolio is the FTSE All-Share Index.

Growth Portfolio

The objective for the Growth Portfolio is to provide investors with capital growth from a diversified portfolio of investment companies.

The focus for the Growth Portfolio is to maximise total returns, principally through capital growth. The Manager is entitled to acquire higher yielding investment companies if it believes such companies will offer superior returns, although it is not expected that such investment companies will form a significant part of the Growth Portfolio.

The Growth Portfolio is diversified through holding at least 25 investment companies. Each investment company provides further diversification through holding a significant number of underlying investments.

The benchmark index for the Growth Portfolio is the FTSE All-Share Index.

Manager's Review

Stockmarket background

In last year's Manager's review particular mention was made of the unprecedented level of uncertainty that prevailed regarding the likely path of the economy and also the equity market over the coming year. In the event, the actual outcome was a second year of returns from UK equities in excess of 20% which was almost certainly much better than most investors had envisaged.

This was achieved against a background which at first glance was not very conducive to positive returns from equities. There was the view that the actions being taken to address the massive budget deficit in terms of cutbacks to public sector spending and higher taxes were not supportive of growth and may lead to a double dip recession in the UK. Also a worry, which grew in importance over the course of the last twelve months, was the high level of inflation in the UK and whether this might force the hand of the Bank of England's monetary policy committee into raising interest rates when domestic activity levels were still subdued. Then there was the all-pervading issue of sovereign debt, in particular in relation to certain countries in the Euro-zone. Bail-outs and severe austerity measures have led to political unrest. For the highly indebted countries of Greece, Ireland, Portugal, and possibly Spain, it is not clear what the eventual outcome will be.

Yet despite the factors highlighted above equities did well.

Perhaps the principal element underpinning the performance was the decision by the Federal Reserve to embark on a second phase of quantitative easing (or "QE2"). This had the effect of providing liquidity to the system with the objective of supporting economic activity in the US. It also had the effect of bolstering

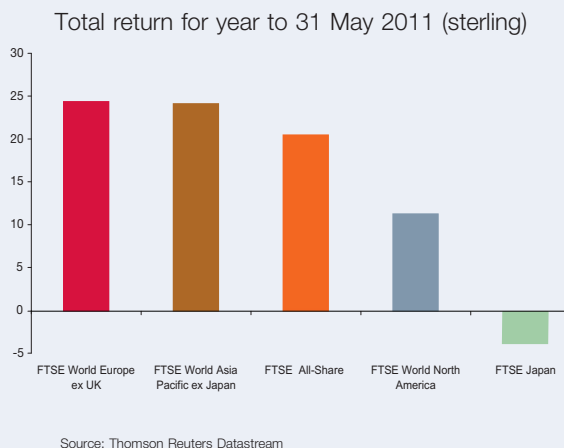
equity markets globally as much of the liquidity created found a home there. With a background of historically very low interest rates (both in the UK and US) and much better than expected corporate profits from companies, equity markets, despite the many concerns which have been outlined, moved ahead usefully over the past twelve months. However a note of caution should be struck as progress since the turn of the calendar year has been much more modest as markets anticipated the end of QE2 and worried over the still faltering performance in terms of growth from many developed economies, especially that of the UK.

Performance

For the year to 31 May 2011 the FTSE All-Share Index rose by 20.4% (in total return terms). Over the same period the Net Asset Value per share for the Income Portfolio returned 24.4% whilst that of the Growth Portfolio was ahead by 24.0% (again both in total return terms). This is the second consecutive financial year that both Portfolios have generated returns ahead of that of the benchmark. For comparative purposes, the FTSE Equity Investment Instruments Index which measures the performance of Investment Companies rose by 21.4% (also in total return terms). The relative outperformance against the FTSE All-Share Index was evident throughout the financial year though was more modest during the second half.

The key factors behind the performance were:

Average sector discounts across the Investment Company sector in general tightened over the past twelve months from 10.3% to 8.0% by the end of the



period. This is beneficial for share prices generally in the Investment Company sector. A combination of share buybacks, corporate activity and retail demand all contributed. The Income Portfolio in particular has benefited from the high ratings accorded to higher yielding investment companies where dividends are perceived to be secure. These ratings reflect the low yield available on gilts and cash deposits.

Gearing. One of the main advantages that investment companies have over their open ended counterparts is the ability to borrow and invest in the markets. Of course this can work against performance should equity price levels decline, however over the past year markets have recorded good gains which will have benefited trusts that have gearing.

Small/Mid Cap effect. When non-FTSE 100 stocks do well this tends to be beneficial for investment companies who have much greater exposure in their portfolios outside of the largest companies. During the past year the FTSE 250 Index rose 28.3% and the FTSE Small Cap Index (ex Investment Companies) gained 23.1% whilst the FTSE 100 Index was ahead by 19.1% (all in total returns). This trend was also evident in Europe and the US.

It should also be noted that the performance of both the Investment Companies sector and F&C Managed Portfolio Trust was achieved despite an adverse move in the important sterling/U.S. dollar exchange rate. During the period under review sterling rose from \$1.446 to \$1.646 an appreciation of nearly 14%. This had the effect of reducing returns, when translated back into sterling, from dollar related overseas equity markets.



Leading Contributors – Income Portfolio (all figures total return)

The leading performer in the Income Portfolio was **Lowland Investment Company** which appreciated by 46.5%. Lowland is a trust which resides in the UK Growth & Income sector and has been managed for a number of years by James Henderson. The key to this outstanding performance lies in the portfolio's exposure outside FTSE 100 stocks. Around one-third is held in mid and one-third in small capitalisation companies with a strong preference for manufacturing and industrial stocks. This type of company performed particularly well over the past year benefiting from strong export growth. **Law Debenture** is another trust run by the same manager and, although having around 30% of its assets overseas, the same themes can be found within the portfolio which has proved highly beneficial for investment performance. The trust gained 36.9% and has a yield of 3.4% slightly above that of Lowland's at 3.1%. **European Assets Trust** was the second strongest performer appreciating 45.0% over the year. The trust has a focus on European mid cap companies, an area that did well and has a yield of 6.1%. Another strong performance came from **Edinburgh Investment Trust** which rose 36.5%. This trust is run by Neil Woodford, one of the UK's most successful investment managers with a clear focus on steady defensive companies which can pay consistent dividends. Its portfolio has no banks or oil companies and has a yield of 4.2%. Finally it is extremely helpful for performance when the largest holding has a strong year; this was the case with **British Assets Trust** which returned 31.7% with a yield of 4.4%.

Leading Contributors – Growth Portfolio (all figures total return)

The largest return was achieved by **Montanaro UK Smaller Companies Investment Trust** which rose by 57.1%. This outstanding performance was achieved through a clear focus on the best quality small and medium sized companies with strong market positions and over 40% of the portfolio was in the industrial sector. **TR Property Investment Trust – Sigma shares** was the next strongest performer with a 52.3% gain. The remit of this trust is property securities throughout Europe with a market capitalisation of less than £1 billion. It has a 70% exposure to Europe with most of that in northern countries like Germany, Sweden and the Netherlands. The property market in these nations has been much more stable and reflects the underlying strength of respective economies. In addition the discount on the

trust has narrowed sharply. For the second year running **Jupiter European Opportunities Trust** has been amongst the strongest contributors; this time with a gain of 51.4%. Typically the manager, Alex Darwall, has a focus on quality growth companies across Europe which has driven performance. Once again this underlines the importance of picking the right manager with a clear investment approach. **Schroder UK Mid Cap Fund** rose by 47.8% and here again a bias to the best performing segment of the UK equity market combined with an experienced management team with proven stock-picking skills resulted in strong performance.

Investment Approach

For investment companies, whilst the discount between the share price and the net asset value is an important element in the decision to invest, and close attention is paid to it, it is not the dominant factor behind the investment selections of F&C Managed Portfolio Trust. The policy which we believe will serve shareholders best is to employ a long-term approach to investment and, as such, the key driver to performance is asset growth over the long-run. Integral to this approach is endeavouring to identify fund managers, within the investment company universe, who can demonstrate good performance records over the long-term either relative to a benchmark index or against a relevant peer group.

Once a potential investment has been identified an analysis of the fundamentals is then undertaken. Examples of factors to focus on include:

- what the prospects are for the relevant market or sector in which the company specialises;
- the need to understand the capital structure, the attitude to and use of gearing, as well as the cost and flexibility of the borrowings;
- meeting with the fund manager regularly to gain an understanding and appreciation of their views and approach and also to ensure that they are properly resourced and not managing too many other funds or different mandates;
- what is the investment style; for example, value or growth and how does this translate into portfolio selections.

Investment Strategy and Outlook

Last year in this section, the very high level of uncertainty that was pervading financial markets,

particularly with regard to economic prospects, was noted. However it was felt much of this was discounted in historically attractive valuations for equities such that although uncertainty was high, the investment stance was one of cautious optimism.

One year on, the prospects for economic activity are more uniform in that the majority of commentators are on balance holding to the view that recovery in the UK economy will continue although the level of growth will be very modest. This recovery is different in that consumers are facing an almost unprecedented squeeze on incomes due to tax rises, inflation and few, if any, pay rises. Exports and manufacturing are doing better and this is helping to rebalance the economy however it is not a "feel good" recovery. All this, contributes to a low level of consumer confidence and preparedness to spend. In the US, the surge of growth experienced after the recession has faded and the pace of activity is slowing which is a concern. Europe is split between severe problems in the south and a remarkably resilient performance from Germany and certain other northern European countries. Pacific and key emerging market economies have had the contrasting problem of overheating, however there are signs that this may be brought under control during the second half of this year. Meantime, and thankfully for the rest of the world, growth should remain robust from countries such as China, India and Brazil.

However, there remains a great deal to be concerned about that could derail the scenario outlined above. Perhaps the most worrisome is the sovereign debt problems of Greece, Ireland and Portugal. Quite what the solution will be is open to debate; however, sovereign default and the break up of the Euro should not be discounted.

If a prolonged period of below trend growth from the UK and many developed economies appears most likely, what does it mean for the prospects for equity markets?

Interestingly, against a background of almost unremittingly poor negative news on the economic front, stockmarkets have been reasonably resilient and so far have held their value. Sentiment however is not good. With the ending of the Federal Reserve's policy of quantitative easing and the near term risks to growth on the downside, it would appear the most vulnerable period for equity markets may be in the coming months.

Looking beyond, it is possible to become more positive with regard to the prospects for equities. Consensus corporate earnings and dividend growth expectations to December 2011 have the UK equity market on a prospective price earnings ratio of 10.5 times with a dividend yield of 3.6%. Whilst not outstandingly cheap, these valuations are still modest and attractive when compared to either the returns on bank deposits or UK gilts where the yield on 10 year gilts is just 3.3%. Markets have been dominated by macro uncertainties; however, should these recede it would pave the way for equity markets, with attractive fundamentals, to move ahead.

Since the inception of F&C Managed Portfolio Trust over three years ago, the principal theme in strategy has been to have, where possible, a bias to overseas growth with the aim of seeking to capture the superior

growth and inherent potential of Pacific and emerging markets. In addition as, over the long term, sterling is viewed as a weak currency, returns should be boosted when translated back into sterling. There seems little cause to change this key element of strategy.

In conclusion, despite the many apparent risks to economies and markets; with attractive valuations and reasonable corporate earnings and dividend growth the Manager approaches the coming year similarly to twelve months ago, with cautious optimism.

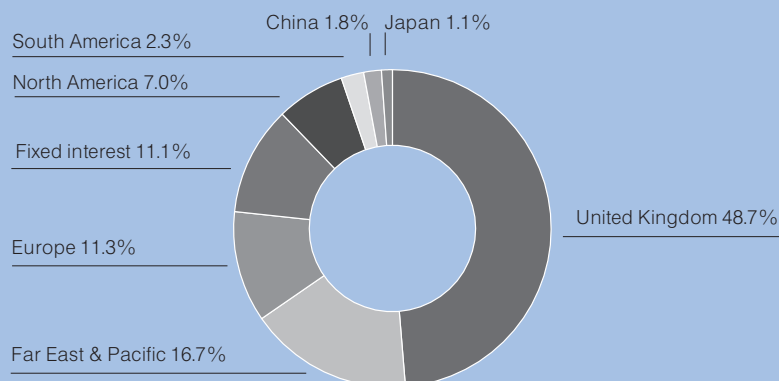

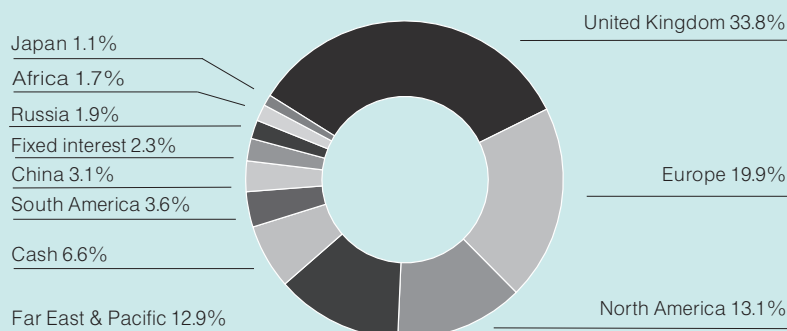

Report of the Directors

The Directors submit the third Annual Report and Accounts of the Company for the year ended 31 May 2011.

Results and Dividends

The results for the year are set out in the attached accounts. The total return attributable to shareholders was £8,474,000 of which £4,552,000 was attributable to the Income Portfolio and £3,922,000 to the Growth Portfolio. Performance and dividends are also addressed within the Business Review on pages 15 to 18. The Manager's Review on pages 8 to 11, which forms part of the Business Review, describes the background to this performance.

Company Number SC338196

Principal Activity and Status

The Company is registered in Scotland as a public limited company in terms of the Companies Act 2006. The Company is an investment company within the terms of section 833 of the Companies Act 2006. Its shares are listed on the official list and traded on the main market of the London Stock Exchange.

The Company has been approved by HM Revenue & Customs as an investment trust under section 1158 of the Corporation Tax Act 2010 for the year ended 31 May 2010. As a result, it is not liable to corporation tax on capital gains. In the opinion of the Directors, the Company has subsequently conducted its affairs so as to enable it to continue to obtain approval as an investment trust.

The Company is required to comply with company law, the rules of the UK Listing Authority, UK Financial Reporting Standards, and its Articles of Association.

The Company is a member of the Association of Investment Companies (the 'AIC').

Business Review

The Board of Directors is responsible for the overall stewardship of the Company, including investment and dividend policies, corporate strategy, gearing, corporate governance and risk management. Biographical details of the Directors, all of whom are non-executive, can be found on page 14.

The following review is designed to provide information primarily about the Company's business and results for the year to 31 May 2011 and covers:

- Investment policy.
- Performance and dividends.
- Management of assets and shareholder value.
- Performance measurement and key performance indicators.
- Principal risks and risk management.

A review of the Company's business during the year, the position of the Company at the year end, and outlook for the coming year is contained in the Chairman's Statement and Manager's Review.

Investment Policy

The Company's investment objective is:

- to provide **Income** shareholders with an attractive level of income with the potential for income and capital growth from a diversified portfolio of investment companies; and
- to provide **Growth** shareholders with capital growth from a diversified portfolio of investment companies.

The **Income** Portfolio will invest in a diversified portfolio of at least 25 investment companies:

- that have underlying investment exposures across a range of geographic regions and sectors.
- that focus on offering an income yield above the yield of the FTSE All-Share Index.

The **Growth** Portfolio will invest in a diversified portfolio of at least 25 investment companies:

- that have underlying investment exposures across a range of geographic regions and sectors.
- the focus of which will be to maximise total returns, principally through capital growth.

The Company invests principally in closed-ended investment companies, wherever incorporated, which are listed on the Official List of the UK Listing Authority. The majority of the Company's holdings comprise equity investments although it is permitted to invest in other securities issued by investment companies.

- The Company is permitted to invest in other closed-ended investment companies, wherever incorporated, whose shares are traded on AiM or a Regulated Exchange (other than the Official List of the UKLA) up to a maximum of 25 per cent of the total assets of the relevant Portfolio.

Report of the Directors (continued)

- In accordance with the Listing Rules of the UK Listing Authority, the Company will not invest more than 10 per cent of its total assets in other UK listed investment companies that themselves may invest more than 15 per cent of their total assets in other UK listed investment companies.
- There are no maximum levels set for underlying exposures to geographic regions or sectors.
- No investment in either Portfolio may exceed 15 per cent of the relevant Portfolio's total assets at the time of the latest purchase.
- The Manager may invest the assets of the Company in other investment companies managed by the Manager, provided that such investments in the Income or Growth Portfolios shall not exceed 20 per cent of the total assets of the relevant Portfolio at the time of investment.
- There are no defined limits on securities and accordingly the Company may invest up to 100 per cent of total assets in any particular type of security.

The Company may use derivatives, principally for the purpose of efficient portfolio management, including protecting the Portfolios against market falls.

The Company may use gearing in either Portfolio. Borrowings are not normally expected to exceed 20 per cent of the total assets of the relevant Portfolio. Under the Company's Articles of Association, the maximum borrowing limit is 50 per cent of the total assets of the relevant Portfolio.

Performance and dividends

Income shares

In the year to 31 May 2011, the NAV total return of the Income shares was 24.4 per cent compared to the benchmark FTSE All-Share Index total return of 20.4 per cent.

During the year, the Company paid three interim dividends totalling 3p per Income share in respect of the year ended 31 May 2011 and has declared a further dividend of 1.4p per Income share which was paid after the year end, on 8 July 2011. These payments totalling 4.4p per Income Share were in respect of the year to 31 May 2011. Based on the historic annual rate of 4.4p per Income share and a share price of 103.0p at the year end, this represents a yield of 4.3 per cent.

Growth shares

In the year to 31 May 2011, the NAV total return of the Growth shares was 24.0 per cent compared to

the benchmark FTSE All-Share Index total return of 20.4 per cent.

Dividends are not paid on the Growth shares, but instead, any net income arising in the Growth Portfolio is transferred to the Income Portfolio and a corresponding transfer of an identical amount made from the capital attributable to the Income Portfolio to the Growth Portfolio. In this regard, in the year to 31 May 2011 a transfer of £89,000 was made between the Portfolios.

Management of Assets and Shareholder Value

As part of its strategy, the Board has contractually delegated the management of the investment portfolios, and other services, to F&C Investment Business Limited.

The Company invests in investment companies which the Manager believes are most appropriate for the Income and Growth portfolios and their objectives.

Investment risks are spread through holding a wide range of investment companies that have underlying investment exposures across a range of geographic regions and sectors. As at 31 May 2011, 31 investments were held in the Income Portfolio and 37 in the Growth Portfolio. At each Board meeting, the Board receives a presentation from the Manager which includes a review of investment performance, recent portfolio activity and market outlook. It also considers compliance with the investment policy and investment restrictions during the reporting period.

The Company has a borrowing facility with its custodian JPMorgan Chase Bank equal to 10 per cent of the value of the Company's assets with its custodian.

The Company's performance in meeting its objectives is measured against key performance indicators ('KPIs') as set out on the following page.

The Chairman's Statement and Manager's Review within this Report provide a review of investment performance, the investment portfolios and market conditions during the year and the outlook for the coming year, both of which form part of this Business Review. An analysis of the Company's Income and Growth Portfolios is contained on pages 12 and 13.

The Board recognises the importance of both marketing and share buy-backs and issuance in enhancing shareholder value. In terms of marketing, the Manager offers a range of private investor

savings schemes, details of which can be found in the 'How to Invest' section of this report. In addition, meetings are held regularly with current and prospective shareholders and stockbroking analysts covering the investment trust sector. Share buy-backs and issuance help reduce the volatility of the discount and enhance the net asset value per share for continuing shareholders. Communication of up-to-date portfolio information is made through the Company's website.

Performance Measurement and Key Performance Indicators

The Board uses a number of performance measures to assess the Company's success in meeting its objectives. The key performance indicators are as follows:

- Net asset value total return of the Income and Growth shares relative to the total return on the FTSE All-Share Index, the benchmark index.
- Dividend level of the Income shares.
- Discount of the share price of the Income and Growth shares, relative to their net asset value.
- Total expenses as a percentage of average net assets.

A record of these indicators is shown below and contained in the page entitled 'Performance Summary' on page 3. Additional comments are provided in the Chairman's Statement and Manager's Review discussing the performance of the Company over the current year.

Principal Risks and Risk Management

The Company's assets consist mainly of listed equity securities and its principal risks are therefore market-related. More detailed explanations of these risks and the way in which they are managed are contained in the notes to the accounts.

Other risks faced by the Company include the following:

- External – events such as terrorism, protectionism, inflation or deflation, economic recessions and movements in interest rates and exchange rates could affect share prices in particular markets.
- Investment and strategic – incorrect strategy, asset allocation, stock selection and the use of gearing could all lead to poor returns for shareholders.

Report of the Directors (continued)

- Credit risk – is the risk that a counterparty will fail to discharge an obligation or commitment that it had entered into with the Company. All the assets of the Company which are traded on a recognised exchange are held by JPMorgan Chase Bank, the Company's custodian. Bankruptcy or insolvency of the custodian may cause the Company's rights with respect to the securities held by the custodian to be delayed or limited.
- Regulatory – breach of regulatory rules could lead to suspension of the Company's Stock Exchange listing, financial penalties, or a qualified audit report. Breach of Chapter 4, Part 24 of the Corporation Tax Act 2010 could lead to the Company being subject to tax on capital gains.
- Operational – failure of the Manager's accounting systems or disruption to the Manager's business, or that of third party service providers, could lead to an inability to provide accurate reporting and monitoring to the Company, leading to a loss of shareholders' confidence.
- Financial – inadequate controls by the Manager or third party service providers could lead to misappropriation of assets of the Company. Inappropriate accounting policies or failure to comply with accounting standards could lead to misreporting or breaches of regulations.

The Board seeks to mitigate and manage these risks through continual review, policy-setting and reliance upon contractual obligations. It also regularly monitors the investment environment and the management of the Company's investment portfolio, and applies the principles detailed in the internal control guidance issued by the Financial Reporting Council. Details of the Company's internal controls are described later in the Report of the Directors.

Directors

The terms of Directors' appointments provide that Directors should retire and be subject to election at the first Annual General Meeting after their appointment. Under the provisions of the Company's articles of association Directors are required to retire at the third Annual General Meeting after the Annual General Meeting at which last elected.

Since 31 May 2011, D Harris has acquired 2,500 Income shares and 2,500 Growth shares. There have been no other changes in the interests of the Directors in the Income shares or Growth shares of the Company since 31 May 2011 up to the date of this report.

No Director has any material interest in any contract to which the Company is a party. No Director has a contract of service with the Company.

Conflicts of Interest

Each Director has a statutory duty to avoid a situation where he has, or could have, a direct or indirect interest which conflicts, or may conflict, with the interests of the Company. A Director will not be in breach of that duty if the relevant matter has been authorised in accordance with the Company's Articles of Association.

The Board has approved a protocol for identifying and dealing with conflicts and has resolved to conduct a regular review of actual or possible conflicts and any authorised conflicts. No conflicts or potential conflicts were identified during the year.

Directors' Deeds of Indemnity

The Company has entered into deeds of indemnity in favour of each of the Directors. The deeds give each Director the benefit of an indemnity to the extent permitted by the Companies Act 2006 against liabilities incurred by each of them in the execution of their duties and the exercise of their powers. A copy of each deed of indemnity is available for inspection at the Company's registered office during normal business hours and will be available for inspection at the Annual General Meeting.

Substantial Interests in Share Capital

At 26 July 2011 the Company had 22,557,192 Income shares and 19,225,567 Growth shares in issue. As at that date the Company had received no notifications of voting rights (under the FSA's Disclosure and Transparency Rules). Since

the launch of the Company, the majority of the Income and Growth shares have been held through the F&C retail share plans. Approximately 92 per cent of the Income shares and 95 per cent of the Growth shares are held in this manner. The voting arrangement for these shares is explained on page 28.

Management and Administration

The Manager provides management, secretarial and administrative services to the Company. A summary of the management agreement between the Company and F&C Investment Business Limited in respect of the services provided is given in notes 4 and 5 to the accounts.

Since the end of the year, the Remuneration Committee has reviewed the appropriateness of the Manager's appointment. In carrying out its review the Committee considered the past investment performance of the Company and the ability of the Manager to produce satisfactory investment performance in the future. It also considered the length of the notice period of the investment management contract and the fees payable to the Manager, together with the standard of other services provided, which include company secretarial, accounting and marketing services. Following this review, it is the Directors' opinion that the continuing appointment of the Manager on the terms agreed is in the interests of shareholders as a whole.

Other Companies Act Disclosures

- The Company's capital structure is explained in the 'Capital Structure' section on pages 27 and 28 of this Annual Report and details of the share capital are set out in note 13 to the accounts. Details of voting rights are also set out in the Notes to the Notice of Annual General Meeting. At 31 May 2011, the total issued share capital of the Company (excluding treasury shares) was represented 54.0 per cent by Income shares and 46.0 per cent by Growth shares.
- The rules for appointment and replacement of Directors are contained in the Articles of Association of the Company. In respect of retirement by rotation, the Articles of Association provide that each Director is required to retire at the third Annual General Meeting after the Annual General Meeting at which last elected.
- Amendment of the Articles of Association and powers to issue and buy back shares require shareholder authority.

- There are no significant restrictions concerning the transfer of securities in the Company (other than certain restrictions imposed by laws and regulations such as insider trading laws); no agreements known to the Company concerning restrictions on the transfer of securities in the Company or on voting rights; and no special rights with regard to control attached to securities. There are no significant agreements which the Company is a party to that might be affected by a change of control of the Company following a takeover bid.
- There are no agreements between the Company and the Directors providing for compensation for loss of office that occurs because of a takeover bid.

Corporate Governance

Arrangements in respect of corporate governance have been put in place by the Board, which it believes are appropriate to an investment trust. The Company complied throughout the year with the provisions of Section 1 of the Combined Code on Corporate Governance issued by the Financial Reporting Council ('the Code') available at website: www.frc.org.uk. The Board has also taken into account the recommendations of the AIC Code of Corporate Governance ('the AIC Code'). Since all the Directors are non-executive, the Company is not required to comply with the provisions of the Code in respect of Directors' remuneration, except in so far as they relate specifically to non-executive Directors.

Under the requirements of the Articles of Association, each Director is subject to re-election at intervals of not more than three years. Directors are appointed for a term of no more than three years as recommended by the Code, subject to reappointment by shareholders. In addition, the terms of Directors' appointments adhere to the requirements of the Companies Act 2006 and Directors are not appointed for a guaranteed term of more than two years without shareholder approval. Full details of the duties of Directors are provided at the time of appointment.

The Board

The Board consists solely of non-executive Directors. Richard Martin is Chairman and David Harris is the Senior Independent Director. All the Directors are considered by the Board to be

independent of the Company's Manager. New Directors receive an induction from the Manager on joining the Board, and all Directors are made aware of appropriate training courses.

The Company has no executive Directors or employees. A management agreement between the Company and its Manager, F&C Investment Business Limited, sets out the matters over which the Manager has authority and the limits beyond which Board approval must be sought. All other matters, including strategy, investment and dividend policies, gearing, corporate governance and risk management procedures, are reserved for the approval of the Board of Directors. The Board currently meets at least four times a year and receives full information on the Company's investment performance, assets, liabilities and other relevant information in advance of Board meetings. The Manager, in the absence of explicit instructions from the Board, is empowered to exercise discretion in the use of the Company's voting rights. All shareholdings are voted where practicable in accordance with the Manager's own corporate governance policy, which is to seek to maximise shareholder value by constructive use of votes at company meetings and by endeavouring to use its influence as an investor with a principled approach to corporate governance. The Company seeks to conduct its affairs responsibly and environmental factors are, where appropriate, taken into consideration with regard to investment decisions on behalf of the Company. The Company's Manager considers socially responsible investment and actively engages with investee companies. The Board notes the Managers' statement of compliance with The UK Stewardship Code issued by the Financial Reporting Council in July 2010, which can be found on its website at www.fandc.com/ukstewardshipcode.

Board Committees

Throughout the year a number of committees have been in existence. The committees are the Audit Committee, the Remuneration Committee and the Nomination Committee. Each of these Committees operate within clearly defined written terms of reference which are available upon request.

Audit Committee

The Audit Committee is chaired by Colin McGill and comprises the whole Board. The duties of the Audit Committee in discharging its responsibilities include

reviewing the Financial Statements, the system of internal controls, and the terms of appointment of the auditors together with their remuneration. The objectivity of the auditors is reviewed by the Audit Committee, which also reviews the terms under which the external auditors are appointed to perform non-audit services. It also provides a forum through which the auditors may report to the Board of Directors and meets at least twice a year. The Audit Committee reviews the scope and results of the audit, its cost effectiveness and the independence and objectivity of the auditors, with particular regard to non-audit fees. Such non-audit fees paid to the Company's auditors, Ernst & Young LLP, amounted to £5,000 for the year ended 31 May 2011, (year to 31 May 2010: £5,000) and related to the provision of taxation services. Notwithstanding such services the Audit Committee considers Ernst & Young LLP to be independent of the Company.

Remuneration Committee

The Remuneration Committee, chaired by Alistair Stewart, comprises the full Board and reviews the appropriateness of the Manager's continuing appointment together with the terms and conditions thereof on a regular basis.

Nomination Committee

The Nomination Committee chaired by Richard Martin, comprises the full Board and is convened for the purpose of considering the appointment of additional Directors as and when appropriate. In considering appointments to the Board, the Nomination Committee takes into account the ongoing requirements of the Company and the need to have a balance of skills and experience within the Board.

During the year the performance of the Board and Committees was evaluated through a formal assessment process, led by the Senior Independent Director. The performance of the Chairman was evaluated by the other Directors under the leadership of the Senior Independent Director. This process involved consideration of completed questionnaires tailored to suit the nature of the Company and discussion of the points arising amongst the Directors. The Board confirms that the performance of each of the Directors continues to be effective and demonstrates commitment to their role.

The table below sets out the number of formal Board and Committee meetings held during the year ended 31 May 2011 and the number of meetings attended by each Director. In addition, short meetings were held during the year to approve the interim dividends and other matters, which had arisen. All Directors attended the annual general meeting ('AGM') in September 2010.

Individual Directors may, at the expense of the Company, seek independent professional advice on any matter that concerns them in the furtherance of their duties. The Company maintains appropriate Directors' and Officers' liability insurance.

Going Concern

The Company's investment objective and policy, which is described on pages 15 and 16 and which is subject to regular Board monitoring processes, is designed to ensure that the Company is invested principally in listed securities. The Company retains title to all assets held by its custodian. Cash is only held with banks approved and regularly reviewed by the Manager. Notes 18 to 23 to the accounts set out the financial risk profile of the Company and indicate the effect on the assets and liabilities of falls (and rises) in the value of securities and market rates of interest.

The Directors believe, in the light of the controls and review processes noted above and bearing in mind the nature of the Company's business and assets and revenue and expenditure projections, that the Company has adequate resources to continue in operational existence for the foreseeable future. For this reason, they continue to adopt the going concern basis in preparing the accounts.

Internal Control

The Board is responsible for the Company's system of internal control and for reviewing its effectiveness. The Board has therefore established an ongoing process designed to meet the particular needs of the Company in managing the risks to which it is exposed, consistent with the guidance provided by

the Turnbull Committee. The process is based principally on the Manager's existing risk-based approach to internal control whereby a matrix is created that identifies the key functions carried out by the Manager and other service providers, the individual activities undertaken within those functions, the risks associated with each activity and the controls employed to minimise those risks. A residual risk rating is then applied. The Board is provided with reports highlighting all material changes to the risk ratings and confirming the action which has been, or is being, taken. A formal annual review of these procedures is carried out by the Audit Committee and includes consideration of internal control reports issued by the Manager and other service providers.

Such review procedures have been in place throughout the financial year and up to the date of approval of the accounts, and the Board is satisfied with the effectiveness of the internal controls. These procedures are designed to manage, rather than eliminate, risk and, by their nature, can only provide reasonable, but not absolute, assurance against material misstatement or loss. At each Board meeting, the Board monitors the investment performance of the Company in comparison to its objective and relevant equity market indices. The Board also reviews the Company's activities since the last Board meeting to ensure that the Manager adheres to the agreed investment policy and approved investment guidelines and, if necessary, approves changes to such policy and guidelines.

The Board has reviewed the need for an internal audit function. The Board has decided that the systems and procedures employed by the Manager,

which are reported on by a firm of external auditors, together with the Manager's internal audit function, provide sufficient assurance that a sound system of internal control, which safeguards the Company's assets, is maintained. In addition, the Company's financial statements are audited by external auditors. An internal audit function, specific to the Company, is therefore considered unnecessary.

Environment

The Company seeks to conduct its affairs responsibly and environmental factors are, where appropriate, taken into consideration with regard to investment decisions taken on behalf of the Company. The Company's Manager considers socially responsible investment and actively engages with investee companies.

Relations with Shareholders

The Company welcomes the views of shareholders and places great importance on communication with its shareholders. The Manager holds meetings with the Company's largest shareholders and reports back to the Board on these meetings. The Chairman and other Directors are available to meet shareholders if required. The Annual General Meeting of the Company provides a forum, both formal and informal, for shareholders to meet and discuss issues with the Directors and Manager of the Company. The notice for the forthcoming Annual General Meeting, to be held on 20 September 2011 is set out on pages 56 to 59.

Creditor Payment Policy

The Company's payment policy is to settle investment transactions in accordance with market practice and to ensure settlement of supplier invoices in accordance with stated terms. The Company did not have any trade creditors at the year end.

Auditors

Ernst & Young LLP have indicated their willingness to continue in office as auditors of the Company and a resolution proposing their re-appointment will be submitted at the forthcoming Annual General Meeting.

Financial Instruments

The Company's financial instruments comprise its investment portfolio, cash balances, bank

borrowings, debtors and creditors that arise directly from its operations such as sales and purchases awaiting settlement and accrued income. The financial risk management objectives and policies arising from its financial instruments and the exposure of the Company to risk are disclosed in notes 18 to 23 to the accounts.

Recommendation

The Directors consider that the passing of the resolutions to be proposed at the Annual General Meeting is in the best interests of the Company and its shareholders as a whole and they unanimously recommend that all shareholders vote in favour of those resolutions. Information on shareholder voting rights is set out in the Notes to the Annual General Meeting.

Directors' Authority to Allot Shares

The Directors are seeking authority to allot Income shares and Growth shares. Resolution 4 will, if passed, authorise the Directors to allot new Income shares up to an aggregate nominal amount of £225,500 consisting of 2,255,000 Income shares and new Growth shares up to an aggregate nominal amount of £192,200 consisting of 1,922,000 Growth shares, being approximately 10 per cent of the total issued Income shares and Growth shares (excluding treasury shares) as at 26 July 2011. This authority therefore authorises the Directors to allot up to 4,177,000 shares in aggregate representing approximately 10 per cent of the total share capital in issue (excluding treasury shares). Resolution 5 will, if passed, authorise the Directors to allot new Income shares up to an aggregate nominal amount of £225,500 and new Growth shares up to an aggregate nominal amount of £192,200, being approximately 10 per cent of the total issued Income shares and Growth shares (excluding treasury shares) as at 26 July 2011, for cash without first offering such shares to existing shareholders pro rata to their existing holdings. This authority therefore authorises the Directors to allot up to 4,177,000 shares in aggregate for cash on a non pre-emptive basis representing approximately 10 per cent of the total share capital in issue (excluding treasury shares). These authorities will continue until the earlier of 20 December 2012 (being 15 months from the date of the Annual General Meeting in 2011) and the conclusion of the Annual General Meeting in 2012. The Directors have no current

intention to exercise this authority and will only allot new shares pursuant to these authorities if they believe it is advantageous to the Company's shareholders to do so and will not result in a dilution of net asset value per share. The Directors consider that the authorisations proposed in resolutions 4 and 5 are necessary to retain flexibility, although they do not intend to exercise the powers conferred by these authorisations at the present time.

Directors' Authority to Buy Back Shares

During the year to 31 May 2011, the Company did not buy back any Income shares for treasury but re-sold 427,000 Income shares out of treasury receiving proceeds of £374,000.

During the year to 31 May 2011, the Company purchased through the market, for treasury 485,000 Growth shares, representing 2.8 per cent of the Growth shares in issue at the previous financial year end, for a total consideration of £493,000. 1,910,000 Growth shares were re-sold during the year from treasury raising net proceeds of £1,771,000

The current authority of the Company to make market purchases of up to 14.99 per cent of each of the issued Income shares and Growth shares (in each case, excluding shares held in treasury) expires at the end of the Annual General Meeting and Resolution 6, as set out in the notice of the Annual General Meeting, seeks renewal of that authority. The renewed authority to make market purchases will be in respect of a maximum of 14.99 per cent of each of the issued Income shares and issued Growth shares (excluding treasury shares) of the Company on the date of the passing of the resolution. The price paid for shares will not be less than the nominal value of 10p per share nor more than the higher of (a) 5 per cent above the average of the middle market values of those shares for the five business days before the shares are purchased and (b) the higher of the last independent trade and the highest current independent bid on the London Stock Exchange. This power will only be exercised if, in the opinion of the Directors, a purchase will result in an increase in net asset value per share and is in the interests of the shareholders. Any shares purchased under this authority will either be held in treasury or cancelled at the determination of the Directors. This authority will expire on the later of 20 December 2012 and the conclusion of the next Annual General Meeting of the Company.

From 1 October 2009, in accordance with the Companies (Share Capital and Acquisition by Company of its own Shares) Regulations 2009, there is no longer a limit on the number of shares that a company can hold in treasury at any one time. The Board has set no limit on the number of shares that can be held in treasury at any one time.

There were 41,782,759 Income shares and Growth shares in issue (excluding treasury shares) as at 26 July 2011; of which 22,557,192 (54.0 per cent) are Income shares and 19,225,567 (46.0 per cent) are Growth shares. At that date, the Company held nil Income shares (nil per cent of the total Income share capital) in treasury and 335,000 Growth shares (1.7 per cent of the total Growth share capital) in treasury.

The Company therefore in aggregate holds 335,000 shares in treasury representing 0.8 per cent of the total share capital in issue.

Treasury Shares

The Board continues to believe that the effective use of treasury shares assists the liquidity in the Company's securities and management of the discount by addressing imbalances between demand and supply for the Company's securities. The discount management policy that was adopted at the time of the Company's launch in 2008 included the ability of the Company to resell treasury shares at a discount to net asset value, subject to certain conditions (see Resolution 7 following).

Resolution 7, if passed, will continue to allow the Company to sell shares from treasury at a discount to net asset value. Shares would only be resold from treasury when market demand is identified and, pursuant to the authority conferred by this resolution, at a price representing a discount of not more than 5 per cent to net asset value at the time of resale, subject to the conditions that, first, the discount at which shares are to be resold must be less than the average discount at which shares of that class held in treasury have been repurchased and, second, the net asset value dilution in any one financial year on the Income shares and the Growth shares respectively must not exceed 0.5 per cent of net assets attributable to the relevant share class. Resolution 7 is conditional on the passing of Resolution 8.

Resolution 8, if passed, will enable the Company to sell shares from treasury without having first to make a pro rata offer to existing shareholders. This authority will be limited to shares representing approximately 10 per cent of the Company's expected issued Income share capital and Growth share capital as at the date of passing of the resolution. Resolution 8 is not conditional on the passing of Resolution 7.

Approval of the proposed Purchase Contract

Resolution 9 gives the Company authority to buy its deferred shares, arising on the conversion of any of the Growth or Income shares into the other class of shares, by way of an off-market purchase in accordance with sections 693 and 694 of the UK Companies Act 2006. The Deferred shares will be purchased for nil consideration (as they have no economic value) in order to keep the balance sheet transparent. The exact number of deferred shares which will arise as a result of any conversions is not yet known and therefore the purchase contract constitutes a contract under section 694(3) of the Companies Act 2006. By law the Company will only be able to purchase these shares off-market if the Purchase Contract is approved by special resolution at a general meeting of the Company.

Statement of Disclosure of Information to Auditors

As far as the Directors are aware, there is no relevant audit information of which the Company's auditors are unaware, and each Director has taken all the steps that he ought to have taken as a Director in order to make himself aware of any relevant audit information and to establish that the Company's auditors are aware of that information.

Individual Savings Accounts

The Company's shares are qualifying investments for Individual Savings Accounts. It is the current intention of the Directors that the Company will continue to conduct its affairs to satisfy this requirement.

Directors' Remuneration Report

The Board has prepared this report in accordance with the requirements of the Companies Act 2006. An ordinary resolution for the approval of this report will be put to shareholders at the forthcoming Annual General Meeting.

The law requires the Company's auditors to audit certain of the disclosures provided in this report. Where disclosures have been audited, they are indicated as such. The auditors' opinion is included in the Independent Auditors' Report.

Directors' Fees and Remuneration Committee

The Board consists solely of independent non-executive Directors and considers annually the level of Directors' fees, in accordance with the Combined Code on Corporate Governance. The Company Secretary provides information on comparative levels of Directors' fees to the Board in advance of each review. The Board concluded following the review of Directors' fees for the forthcoming year that the amounts paid to Directors should at present remain unchanged.

The Remuneration Committee comprises Alistair Stewart (Chairman), Richard Martin, David Harris and Colin McGill. As the Company has no executive Directors, the Committee will meet at least annually, to review the remuneration and terms of appointment of the Manager.

Policy on Directors' Fees

The Board's policy is that the remuneration of non-executive Directors should reflect the experience of the Board as a whole, be fair and comparable to that of other relevant investment trusts that are similar in size and have similar investment objectives and structures. Furthermore the level of remuneration should be sufficient to attract and retain the Directors needed to oversee properly the Company and to reflect the specific circumstances of the Company, the duties and responsibilities of the Directors and the value and amount of time committed to the Company's affairs.

The fees for the non-executive Directors are determined within the limits set out in the Company's Articles of Association. The present limit

is £120,000 per annum in aggregate and the approval of shareholders in a general meeting would be required to change this limit. Non-executive Directors are not eligible for bonuses, pension benefits, share options, long-term incentive schemes or other benefits.

Directors' Service Contracts

It is the Board's policy that Directors do not have service contracts, but new Directors are provided with a letter of appointment.

The terms of Directors' appointments provide that Directors should retire and be subject to election at the first Annual General Meeting after their appointment. Directors are thereafter obliged to retire periodically, and to offer themselves for re-election by shareholders at the third annual general meeting after the annual general meeting at which last elected.

These requirements for the retirement of Directors are also contained in the Company's Articles of Association. There is a one month's notice period and no provision for compensation upon early termination of appointment.

Company Performance

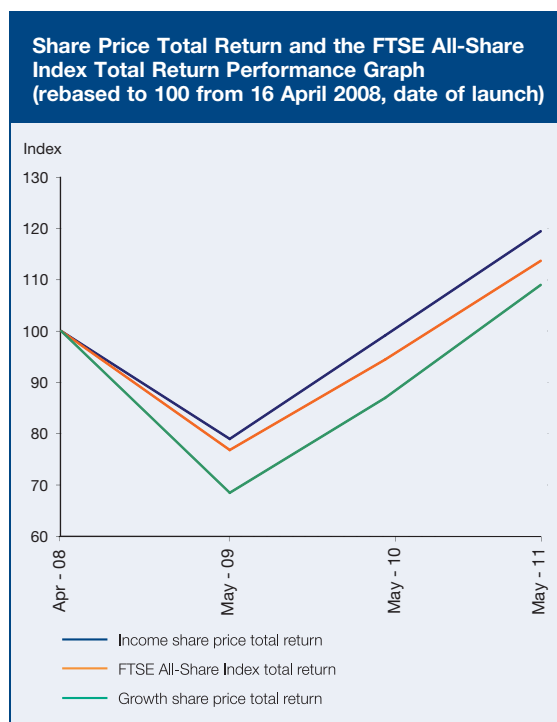

Capital Structure

At 31 May 2011

The Company has a capital structure comprising Income shares and Growth shares.

The Company has two classes of shares, Income shares and Growth shares, each with distinct investment objectives, investment policies and underlying asset portfolios. Both the Income shares and Growth shares are listed on the London Stock Exchange. There is no fixed ratio of Income shares to Growth shares and the relative sizes of the Income and Growth portfolios will vary over time.

Neither the Income shares nor the Growth shares represent capital gearing for the other share class.

Dividends

Income shares are entitled to all dividends of the Company. It is expected that the Company will pay four quarterly dividends per financial year. The Growth shares do not carry an entitlement to receive dividends.

Any net income arising in the Growth Portfolio is transferred to the Income Portfolio, and a corresponding transfer of an identical amount made from the capital attributable to the Income Portfolio to the Growth Portfolio. It is expected that this will both benefit the income prospects of the Income shares and the capital growth prospects of the Growth shares.

Capital

The net asset value of the Income shares is based on the Income Portfolio and the net asset value of the Growth shares is based on the Growth Portfolio.

As a matter of law, the Company is a single entity and, while under the articles of association the assets of the Income Portfolio are separated for the benefit of the Income shareholders and the assets of the Growth Portfolio are separated for the benefit of the Growth shareholders, there is no distinction between the assets of the Income Portfolio and the Growth Portfolio as far as creditors of the Company are concerned.

On a return of assets, on a liquidation or otherwise, the surplus assets of the Company comprised in either of the Income Portfolio or the Growth Portfolio, after payment of all debts and satisfaction of all the liabilities associated with that Portfolio and any other relevant liabilities, shall be paid to the holders of the shares of the particular Portfolio and distributed amongst such holders rateably according to the amounts paid up on the relevant shares held by them respectively.

If, in the course of liquidation of the Company the assets attributable to a particular Portfolio are insufficient to satisfy the liabilities attributable to that Portfolio and that Portfolio's pro rata share of the Company's general liabilities, the outstanding liabilities shall be attributable to the other Portfolio.

Voting

At any general meeting of the Company, on a show of hands, each Income shareholder and each Growth shareholder shall have one vote and, upon a poll, a weighted vote determined in accordance with the underlying NAV of the relevant share as specified in the Articles.

At any class meeting of Income shareholders, on a show of hands, each Income shareholder shall have one vote and, upon a poll, one vote for each Income share held and at any class meeting of Growth shareholders, on a show of hands, each Growth shareholder shall have one vote and, upon a poll, one vote for each Growth share held.

Capital Structure (continued)

Holders of shares of one class will not, however, have the right to vote at a general meeting of the Company on any resolution in relation to changes (material or otherwise) to the investment policy of the other Portfolio or on any other resolutions which the Board determines are not relevant to the holders of shares in that particular Portfolio.

Voting of shares held in the Share Plans

Since the launch of the Company, the majority of the Income and Growth shares in the Company have been held through the Share Plans which are administered by the Manager. The Manager agreed to waive all rights it would otherwise have had to vote those shares held through the Share Plans at its discretion and agreed to vote the shares in accordance with the instructions of the underlying shareholders. The Manager agreed that, subject to any regulatory restrictions, it would operate a proportional voting system whereby, provided it received instructions to vote in respect of more than 10 per cent of the shares held in the Share Plans, it would vote all the shares in respect of which it had not received instructions proportionately to those for which it had received instructions, except that any shares held by the underlying holder in excess of 0.25 per cent of the issued shares of the relevant class would not be counted for the purposes of pro-rating the voting of non-directed shares. Any shares voted by an underlying shareholder in excess of the maximum limit would remain valid, but would not form part of the proportional voting basis.

Conversion between Income and Growth shares

Subject to certain minimum and maximum thresholds, shareholders have the right to convert their Income shares into Growth shares and/or their Growth shares into Income shares upon certain dates, the next of which will be in October 2011 and then annually thereafter. Under current law, such conversions will not be treated as disposals for UK capital gains tax purposes.

The ratio in which shares convert will be determined on a relative net asset value basis as at the Conversion Date, adjusted for any dividends that will go ex-dividend prior to the Conversion Date and such that the converting shares bear the costs of conversion. Upon conversion, the converted shares shall rank *pari passu* with all other shares of its new class.

The Board may from time to time set a maximum number of Income or Growth shares which may be converted on any Conversion Date. If this limit is exceeded, requests to convert will be satisfied pro rata by the total number of shares each Shareholder wished to convert and any shares above those amounts shall not be converted. Full details are provided in the Shareholder Information section on pages 53 and 54.

Statement of Directors' Responsibilities

Statement of Directors' Responsibilities in Respect of the Annual Report and the Financial Statements

The Directors are responsible for preparing the Annual Report and the financial statements in accordance with applicable law and regulations.

Company law requires the Directors to prepare financial statements for each financial year. Under the law they have elected to prepare the financial statements in accordance with UK Accounting Standards. The financial statements are required by law to give a true and fair view of the state of affairs of the Company and of the profit or loss of the Company for that period.

In preparing these financial statements, the Directors are required to:

- select suitable accounting policies and then apply them consistently;
- make judgments and estimates that are reasonable and prudent;
- state whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Company will continue in business.

The Directors are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the Company and enable them to ensure that its financial statements comply with the Companies Act 2006. They have general responsibility for taking such steps as are reasonably open to them to

safeguard the assets of the Company and to prevent and detect fraud and other irregularities.

Under applicable law and regulations, the Directors are also responsible for preparing a Directors' Report (including a Business Review), Directors' Remuneration Report and Corporate Governance Statement that comply with that law and those regulations.

The Directors are responsible for the maintenance and integrity of the corporate and financial information included on the Company's website. Legislation in the UK governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

The Directors confirm that to the best of their knowledge:

- the financial statements, prepared in accordance with the applicable set of accounting standards, give a true and fair view of the assets, liabilities, financial position and profit or loss of the Company; and
- the Chairman's Statement, Manager's Review and Business Review contained within the Report of the Directors (together constituting the Management Report) include a fair review of the development and performance of the business and the position of the Company together with a description of the principal risks and uncertainties that it faces.

Notes to the Accounts

1. Accounting policies

A summary of the principal accounting policies adopted is set out below.

(a) Basis of accounting

These financial statements have been prepared under UK Generally Accepted Accounting Practice ("UK GAAP") and in accordance with guidelines set out in the Statement of Recommended Practice ("SORP"), for Investment Trust Companies and Venture Capital Trusts issued by the Association of Investment Companies ("AIC") in January 2009.

Presentation of the Income Statement

In order to reflect better the activities of an investment trust company and in accordance with the SORP, supplementary information which analyses the Income Statement between items of a revenue and capital nature has been presented alongside the Income Statement. The net revenue return is the measure the Directors believe to be appropriate in assessing the Company's compliance with certain requirements set out in Chapter 4, Part 24 of the Corporation Tax Act 2010.

The notes and financial statements are presented in pounds sterling and are rounded to the nearest thousand except where otherwise indicated.

(b) Valuation of investments

The Company's business is investing in financial assets with a view to profiting from their total return in the form of income and capital growth and the Company's investments have been categorised as "financial assets at fair value through profit or loss". Purchases are recognised on the relevant trade date, inclusive of expenses which are incidental to their acquisition. Sales are also recognised on the trade date, after deducting expenses incidental to the sales. At the time of acquisition the investments are valued at cost of purchase.

Listed and quoted investments are valued at their fair value which is represented by the bid price at the close of business on the relevant date on the exchange on which the investment is quoted.

As investments have been categorised as "financial assets at fair value through profit or loss," gains and losses arising from changes in fair value are included in the Income Statement as a capital item.

(c) Income

Dividends are recognised as income on the date that the related investments are marked ex-dividend.

Dividends receivable on equity shares where no ex-dividend date is quoted are brought into account when the Company's right to receive payment is established. Dividends from overseas companies are shown gross of any withholding tax.

Other investment income and deposit interest are included on an accruals basis.

Interest income from fixed interest securities is accrued on a time apportioned basis, by reference to the principal outstanding and at the effective interest rate applicable.

Where the Company has elected to receive its dividends in the form of additional shares rather than cash, the amount of the cash dividend foregone is recognised as income.

Special dividends are recognised in the revenue account unless they are of a capital nature, following which they will be recognised in the capital account.

(d) Expenses

All expenses and interest are accounted for on an accruals basis. Expenses are charged to the Income Statement as a revenue item except where incurred in connection with the maintenance or enhancement of the value of the Company's investment portfolio and taking account of the expected long-term returns as follows:

- Management fees and finance costs have been allocated 40 per cent to revenue and 60 per cent to capital in the Income Portfolio and 20 per cent to revenue and 80 per cent to capital in the Growth Portfolio;
- Performance fees have been charged wholly to capital.

Expenses charged to the Company common to both Portfolios are allocated to the Portfolios in the same proportion as their net assets at the quarter end immediately preceding the date on which the cost is to be accounted for.

Expenses charged to the Company in relation to a specific Portfolio are charged directly to that Portfolio, with the other Portfolio remaining unaffected.

Notes to the Accounts (continued)

1. Accounting policies (continued)

(e) Taxation

The tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the period. Taxable profit differs from profit before tax as reported in the income statement because it excludes items of income or expense that are taxable or deductible in other periods and it further excludes items that are never taxable or deductible. The Company's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the balance sheet date.

Tax is computed for each Portfolio separately, however the Company is the taxable entity. A Portfolio which generates taxable revenues in excess of tax deductible expenses may benefit from the excess of tax deductible expenses in the other Portfolio. In return, by way of compensation, there would be a transfer from the Portfolio with taxable profits to the Portfolio with taxable losses.

(f) Deferred taxation

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events that result in an obligation to pay more, or right to pay less, tax in future have occurred at the balance sheet date. This is subject to deferred tax assets only being recognised if it is considered more likely than not there will be suitable profits from which the future reversal of the underlying timing differences can be deducted. Timing differences are differences arising between the Company's taxable profits and its results as stated in the accounts which are capable of reversal in one or more subsequent periods.

Investment trusts which have approval under Chapter 4, Part 24 of the Corporation Tax Act 2010 are not liable for taxation on capital gains.

(g) Debt instruments

Interest-bearing loans and overdrafts are recorded at the proceeds received, net of any issue costs. Finance charges, including interest are accrued using the effective interest rate method. See 1(d) for the allocation of finance costs.

(h) Foreign currencies

Transactions denominated in foreign currencies are recorded in the local currency at actual exchange rates as at the date of the transaction. Monetary assets and liabilities denominated in foreign currencies at the period end are reported at the rates of exchange prevailing at the period end. Any gain or loss arising from a change in exchange rates subsequent to the date of the transaction is included as an exchange gain or loss in either the capital or revenue column of the income statement depending on whether the gain or loss is of a capital or revenue nature respectively.

(i) Reserves

- (a) Share premium – the surplus of net proceeds received from the issuance of new shares over their par value is credited to this account and the related issue costs are deducted from this account. Gains arising on the resale of shares from treasury are credited to this reserve. The reserve is non-distributable. The balance of this account which arose as a result of the issue of new shares at launch was subsequently cancelled by the Court of Session to create the Special reserve.
- (b) Capital redemption reserve – the nominal value of any of the shares bought back for cancellation is added to this reserve. This reserve is non-distributable.
- (c) Special reserve – created from the Court cancellation of the share premium account which had arisen from premiums paid on the Income and Growth shares at launch. Available as distributable profits to be used for the buy back of shares. The cost of any shares bought back is deducted from this reserve. The cost of any shares resold from treasury is added back to this reserve.
- (d) Capital reserve – investments sold – gains and losses on realisation of investments, including losses on transactions in own shares, are dealt with in this reserve together with the proportion of management fees, interest and taxation allocated to capital. This reserve also includes dividends of a capital nature.
- (e) Capital reserve – investments held – increases and decreases in the valuation of investments held are accounted for in this reserve.
- (f) Revenue reserve – the net profit/(loss) arising in the revenue column of the Income Statement is added to or deducted from this reserve. Available for paying dividends on the Income shares.

1. Accounting policies (continued)

(j) Transfer of capital and revenue

All net revenue of the Company attributable to the Growth Portfolio is, immediately following recognition in accordance with the Company's accounting policies, reallocated, applied and transferred to, and treated as revenue attributable to, the Income Portfolio. Contemporaneously with any such reallocation, application and transfer of any revenue to the Income Portfolio, such assets comprising part of the Income Portfolio as have a value equal to the net revenue so reallocated, applied and transferred shall be reallocated, applied, transferred and treated as capital attributable to the Growth Portfolio.

2. Segmental analysis

The Company carries on business as an investment trust and manages two separate portfolios of assets: the Income Portfolio and the Growth Portfolio.

The Company's investment manager is F&C Investment Business Limited. F&C Investment Business Limited receives an investment management fee comprising a base fee and, if certain conditions are met, a performance fee.

The base fee is a management fee at the rate of 0.65 per cent per annum of the total assets of each Portfolio payable quarterly in arrears, subject to being reduced to 0.325 per cent per annum on any assets which are invested in other investment vehicles managed by the Manager.

For the purposes of the revenue and capital columns in the income statement, the management fee has been allocated 60 per cent to capital and 40 per cent to revenue in the Income Portfolio. In respect of the Growth Portfolio, the base management fee has been charged 80 per cent to capital and 20 per cent to revenue.

A performance fee may be payable annually and is equal to 10 per cent of the monetary amount by which the total return of the relevant Portfolio over that year (after all costs and expenses excluding the Performance fee) exceeds the total return on the FTSE All-Share Index (in each case with dividends reinvested).

The performance fee payable in respect of any one year is capped at 0.35 per cent of the total assets of the relevant Portfolio and is charged wholly to capital.

4. Investment management and performance fee (continued)

In the event that a Portfolio has outperformed the benchmark index such that a performance fee would be payable as described above, but the NAV per share for the relevant portfolio at the end of the financial year is less than (i) the NAV per share at the start of the financial year or (ii) the NAV per share immediately following Admission, whichever is the higher, (the "Watermark NAV") payment of the Performance fee in respect of that financial year shall be deferred until the end of the next financial year when the NAV per share for the relevant portfolio is in excess of the Watermark NAV. If the Watermark NAV is not reached by the end of the fourth financial year subsequently, it will no longer be payable. Any underperformance of the relevant Portfolio in relation to the FTSE All-Share Index in any financial year must be made up in any subsequent financial year before any Performance fee is payable, thereby creating a "high watermark" for the relative performance against the FTSE All-Share Index.

At 31 May 2011 the total return of the Income Portfolio for the year exceeded that of the FTSE All-Share Index and a Performance fee of £71,000 (2010: £7,000) has been recognised. As the NAV per Income share is greater than the Watermark NAV of 98p (NAV per Income share immediately following Admission) this fee, together with the 2010 and 2009 performance fees of £7,000 and £39,000 respectively, which had been accrued, will now be paid. At 31 May 2011 the total return of the Growth Portfolio since launch did not exceed that of the FTSE All-Share Index.

The Investment Management Agreement between the Company and F&C Investment Business Limited is terminable by either party on six months' notice. The Company may terminate the Agreement early upon payment of an amount equal to the base fee which would have been payable had the notice period been complied with plus any performance fee accrued at termination.

Credit risk arising on transactions with brokers relates to transactions awaiting settlement. Risk relating to unsettled transactions is considered to be small due to the short settlement period involved and the acceptable credit quality of the brokers used. The Manager monitors the quality of service provided by the brokers used to further mitigate this risk.

All the assets of the Company which are traded on a recognised exchange are held by JPMorgan Chase Bank, the Company's custodian. Bankruptcy or insolvency of the custodian may cause the Company's rights with respect to securities held by the custodian to be delayed or limited. The Board monitors the Company's risk by reviewing the custodian's internal control reports as described in the Report of the Directors.

The credit risk on liquid funds is controlled because the counterparties are banks with acceptable credit ratings, normally rated AA or higher, assigned by international credit rating agencies. Conversion Facility

Subject to certain minimum and maximum thresholds which may be set by the Board of F&C Managed Portfolio Trust plc (the "Board") from time to time, shareholders have the right to convert their Income shares into Growth shares and/or their Growth shares into Income shares upon certain dates, the next of which will be 28 October 2011 and then annually or close to annually thereafter (subject to the articles of association of the Company). Under current law, such conversions will not be treated as disposals for UK capital gains tax purposes.

Conversion Process

Minimum level

The Board may, in its sole and absolute discretion, specify a minimum number of converting shares which are to be converted by a shareholder in the case of either the Income shares or Growth shares.

It is anticipated that, within 7 working days of the Conversion Date or the Deferred Conversion Date, the Company will send to each holder of converting shares that are in certificated form a definitive certificate for the appropriate number of shares arising on conversion and a new certificate for any unconverted shares. No share certificates will be issued in respect of any deferred shares arising as a result of the conversion. These deferred shares have no economic value and will be automatically transferred to a nominee holder or bought back for nil consideration by the Company in accordance with the Company's articles of association.

Income shares arising on Conversion will carry the right to receive all dividends declared by reference to a record date falling after the Conversion Date or Deferred Conversion Date. Income shares which are converted into Growth shares will carry the right to receive all dividends declared by reference to a record date falling prior to the Conversion Date or Deferred Conversion Date but not on or thereafter.
