What is this product?

Type

This product is an investment fund.

Term

There is no maturity date applicable to this product.

All of the Shares may be redeemed by the Company with the sanction of a special resolution of Shareholders, on no less than three weeks' notice to Shareholders at a sum equal to the Net Asset Value per Share.

In addition, the Company may, on no less than three weeks' notice to Shareholders, redeem all Shares issued if: (i) the Company is no longer authorised by the Central Bank as an investment company pursuant to Part 24 of the Companies Act 2014; or (ii) any law that has been passed renders it illegal or, in the reasonable opinion of the Directors of the Company, impracticable or inadvisable to continue the Company; or (iii) at any time following the Initial Offer Period, the Net Asset Value of the Company, any one Class or any one Fund shall on any Dealing Day within a period of one week is less than EUR75 million (or its currency equivalent), provided that notice of not less than four and not more than six weeks has been given to the Shareholders within four weeks of such period.

Objectives

Investment objective The fund aims to provide a stable stream of returns that beats the rate of inflation over the long term while at the same time minimising volatility and aiming to protect investors from losses as compared to the market. The fund is actively managed and aims to achieve a return similar to or better than the UK Retail Price Index (RPI) (the "Benchmark"). The fund is not constrained by this Benchmark. The fund invests in high quality fixed interest debt issued by governments and equities (shares) of companies that, at the time of purchase, have a minimum stock market worth of US\$500 million. The fund can invest worldwide, however it places particular emphasis on North America, Europe (including the UK) and the Asia Pacific Region (including Japan). The fund will have significant exposure to pound sterling-denominated assets.

Investment policies The fund may invest up to 20% of its assets in the global emerging markets and up to 25% of its assets in cash.

Forward foreign exchange transactions may be used to reduce the risk of adverse market changes in exchange rates.

For temporary defensive purposes, the fund may invest, without limitation, in money market instruments.

The fund may invest in other types of eligible investments, as disclosed in the prospectus for the fund.

Share Class Benchmark UK Retail Price Index (RPI)

Benchmark uses The Fund is actively managed. The majority of issuers in the Fund are likely to be represented in the benchmark because the Investment Manager uses it as a basis for portfolio construction, but has some discretion to deviate from its composition and risk characteristics within indicative risk parameters. The Fund will resemble the composition and risk characteristics of its benchmark; however, the Investment Manager's discretion may result in performance that differs from the benchmark.

Redemption and Dealing Shares of the Fund may be redeemed on demand, with dealing normally on a daily basis.

Distribution Policy This Share Class does not pay dividends. Earned income is retained in the NAV.

Intended retail investor

This product is intended for investors who plan to stay invested for at least 3 years and are prepared to take on a medium-low level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

What are the risks and what could I get in return?

Risks

What happens if Pyrford International Ltd is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should we default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of Pyrford International Ltd to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
